## Registration Fees

- NFRA Member fee is \$650. Conference fees include all conference materials, speaker presentations and Monday/Tuesday receptions.
- NFRA Member not staying at Tempe Mission Palms Hotel fee is \$875 per registrant. This fee is required for individuals not staying at the Tempe Mission Palms Hotel to cover conference expenses. This would include conference materials, meals/breaks and service charges from the hotel.
- NFRA Member Retailers receive complimentary registration.
- NFRA Non-Member fee is \$1,300.
- Non-Member not staying at the Tempe Mission Palms Hotel fee is \$1,750 per registrant.

## Hotel Information/Fees

The Tempe Mission Palms will serve as the Headquarters for the 2010 Retail Executive Conference. It is located just ten minutes from Phoenix Sky Harbor Airport in downtown Tempe. The special package rates are \$297.50 for single occupancy and \$205 per person for double occupancy. All room rates are subject to state and local taxes. This rate is a per person/per day charge and includes guest room, Welcome Reception on Monday, breakfast, lunch, reception and dinner on Tuesday, breakfast on Wednesday and continuous morning and afternoon coffee breaks. This rate also includes local and toll free telephone calls, incoming and outgoing fax services, daily newspaper, in-room coffee service, airport transportation, wireless high speed internet access, parking and access to the fitness center. A special room rate of \$185 is available 3 days before and 3 days after the conference and is a room charge only.

## Golf Tournament/Fees

An optional golf tournament will be held on Monday afternoon, April 26th at the Whirlwind Golf Club about 30 minutes away from hotel. The golf fees are \$120 per player, which includes lunch, greens fees, cart, prizes, refreshments on the course, and transportation. Golf fees must be mailed with registration fees. Cancellations must be received 48 hours in advance in order to receive a refund. Transportation will depart from Tempe Mission Palms Hotel at 12 noon.

## Bass Fishing Tournament/Fees

**New to the agenda this year is the NFRA Fishing Tournament that will be held on Monday afternoon, April 26th, at Lake Pleasant about 45 minutes from the Tempe Mission Palms Hotel. The fishing fees are \$150 per person which includes full line of fishing equipment, guide, refreshments and transportation. Transportation will depart from the Tempe Mission Palms Hotel at 12 noon. Fishing Fees must be submitted with registration fees.**

## Cancellation Policy
